CAFB'S STRATEGIC PLAN:

A Hunger-Free California



CAFB is committed to ensuring every Californian has access to nutritious food. Our strategic plan is built on our key pillars:

PILLAR 1:

Food

Increase food resources available to feed California.

PILLAR 2:

Advocacy

Drive political and public will to end hunger in California.

PILLAR 3:

Strengthening the Network

Strengthen the California food safety network with expertise, capacity, and connections to drive our shared mission to end hunger.

PILLAR 1

Food

In 2024, CAFB's Farm to Family program partnered with 103 farmers and all 41 member food banks to recover and distribute 274 million pounds of food, ensuring fresh, nutritious options reached communities across California.

To further support small and remote food banks, CAFB established a mixing center in Lodi, repacking and delivering fresh, mixed-produce loads to food banks that previously had limited access.

This initiative was part of the Removing Barriers to Fresh Produce Project, a \$1 million, two-year effort launched in 2023 to enhance food bank capacity



through logistics coordination, cold storage rentals, and equipment upgrades like forklifts and pallet jacks. As a result, produce distribution to these food banks increased by 911% from 2022, significantly expanding access to fresh food across the state.

What's Next for Food?

Looking ahead, CAFB will continue sourcing California's excess produce, with a goal of distributing more than 280 million pounds by 2027 through its Farm to Family program. By enhancing procurement and logistics services, CAFB will better support food banks, ensuring that fresh, nutritious food reaches communities facing the greatest barriers.

PILLAR 2

Policy & Advocacy

Despite a \$72 billion State budget deficit and shifting political landscape in 2024, CAFB remained steadfast in strengthening California's food safety net.

Through policy advocacy and strategic partnerships, we secured key policy wins, protected critical funding, and ensured food banks had the resources needed to serve their communities.

To support informed decision-making, CAFB expanded interactive dashboards, providing real-time data to help our network refine policies and maximize impact. Our research tracks poverty,



housing, wages, and CalFresh participation, ensuring data-driven solutions that address food insecurity at its root. With a growing coalition of 120+ advocates engaging 120+ legislative offices, CAFB continues to build momentum—leveraging data and advocacy to advance policies that fight hunger and strengthen food access for all Californians.

Through research, advocacy, and innovation, we are building a stronger, more equitable food system for all.

PILLAR 3

Strengthening the Network

Building a resilient food safety net requires equipping food banks and partners with the tools, knowledge, and support needed to expand food access and address the root causes of hunger.

At the start of 2024, CAFB played a pivotal role in supporting Disaster CalFresh efforts in San Diego, ensuring that families affected by emergencies could access critical nutrition assistance. In May, Food ACCESS, CAFB's biennial conference, brought

together leaders from across California and the nation to collaborate on policy solutions and strategies to strengthen food access and combat hunger.

CAFB continued to provide training to 50+ outreach groups statewide, helping remove barriers to CalFresh enrollment and increase participation among eligible households. Additionally, CAFB delivered critical resources, facilitated impactful peer discussions, and actively supported the strengthening of rural food banks, all in service of advancing our united efforts to end hunger in California.

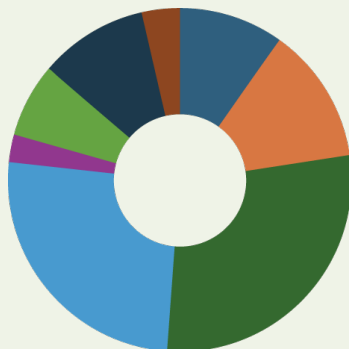

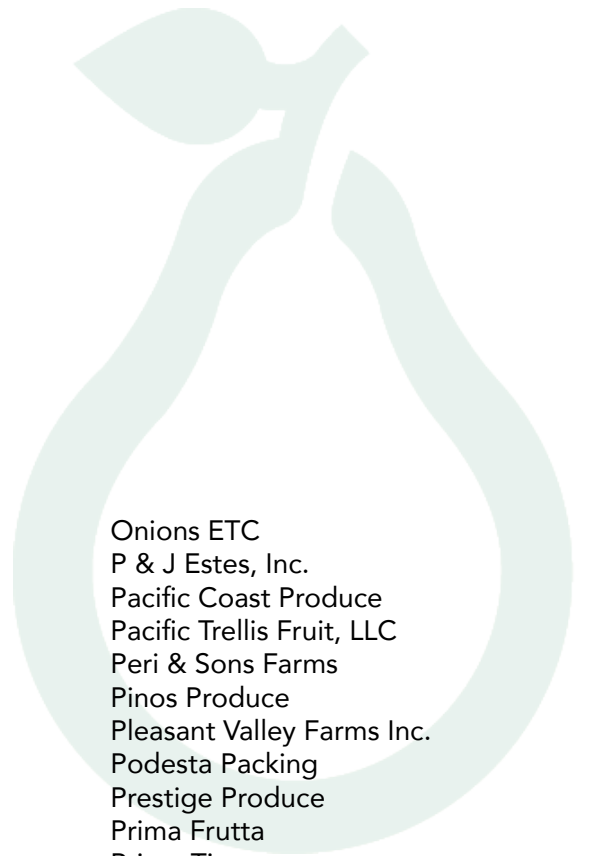

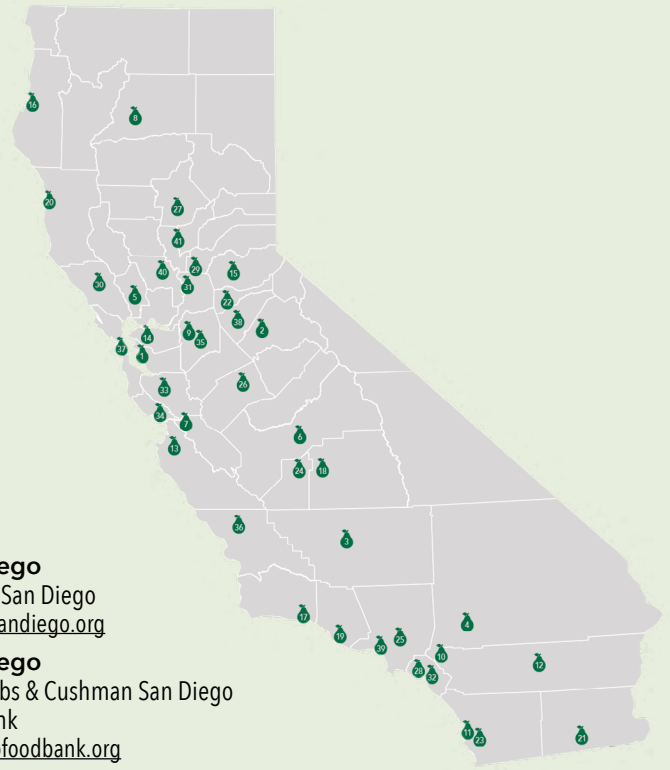
